A motion to accept the December 29, 2020 minutes as read was made by Arnold Lobdell and seconded by Tim Crippen. Roll Call: Arnold aye, Tim aye, Pat absent, Jim aye and Bill aye.

A motion was made by Bill Wood and seconded by Tim Crippen to pay Judy Tavernier one half of the Town Clerk Salary per month while she is training for the position through April 1, 2021. - 3. A letter dated January 12, 2021 was received from June Parmeter stating her regret that she does not wish to be considered for the vacant Burke Town Councilmember position. A motion was made by Bill Wood and seconded by Jim Otis for the Town Board to go into Executive Session at 7:40 P.M. to discuss appointing a person to fill the position of Burke Town Councilmember due to the resignation of Town Councilman, Pat Downing. The Board returned from Executive Session at 7:45 P.M. A motion was made by Bill Wood and seconded by Jim Otis to appoint Keith Trudeau to the office of Burke Town Councilmember from January 1, 2021 to December 31, 2021. - 4. Oaths of Office were given by the Town Clerk to Deputy Supervisor, Jim Otis, Councilmember, Keith Trudeau and new Town Clerk, Judy Tavernier.
- 5. Barton Pitts of NEXAMP will attend the February 9, 2021 Board meeting to discuss the progress of the Burke Solar LLC project. Noise studies and a

- proposed Landscape plan are being worked on with the Town of Burke's legal representative and engineering firm.
- 6. Jim Gonyo, Burke Assessor, sent the Board a letter from the New York State Department of Taxation and Finance designating Burke's assessed value at 99.12% which is considered at 100%.
- 7. Preliminary insurance values were discussed with Pat McGuire, of NYMIR, on January 6, 2021. Pat McGuire will attend the February 2021 Monthly Meeting.
- 8. Eric Gustafson, the USDA Grant/Loan Bond Consul, will be getting the final paperwork for the USDA Grant/Loan soon.
- 9. Franklin County and NYMIR have each sent documents giving the Town of Burke a plan to use to draft the NYS Governor's Public Employer Health Emergency Plan that town's need to have to submit to the unions that towns use by February 2021. The NYMIR plan looks like the model that the Town of Burke should use.

- 5. Air valves were replaced on the 04 Mack.
- 6. A bad wire was found on the 09 Mach.
- 7. The shaft was bad on the Ford F-250.

8. The new Volvo Plow Truck should have its plow package installed by next week.
