Bill Buckley, NYSLRS has agreed to a web conference on 11/16/2021 at 6:00 p.m. to answer questions regarding the estimate provided by Bill Buckley.

Thayers Corner Water District representative, Dale Parmeter will be meeting with engineers on 11/17/2021 to discuss options for water district. Changes to the water district were discussed.

Brian Stewart has informed us of the new requirement by New York State that all resolutions must be posted as a public notice at least 24 hours before they are voted on at a regular meeting.

Bank was unable to provide a new amortization schedule for repayment of truck after our \$20,000 payment.

Some changes were made to the Thayers Corner Water District Budget to adjust accounts for more accurate usage. Final Budget shows corrections to preliminary budget discussed at last work session. We remain \$30,000 over the Tax Cap.
