- 1. Anne Waling, representative from Terra Gen provided an update for the project. Some studies and tests remain. Anticipate submitting applications by November or December next year.
- 2. Lorelei Miller, town justice submitted a letter of resignation effective 12/31/2023. - 3. Dog Control Officer Two bids were received, however George Millard has since withdrawn his bid. Jim McHugh outlined his services for dog control with 2 options, one including mileage and one without. After discussion, it was decided to accept his bid of \$3,000.00, including mileage. He will be paid bi-annually in January and September. Dogs will continue to be sheltered at Bangor Animal Shelter. Tim Crippen made this RESOLUTION # 19-2023 to approve the contract with James McHugh. Paddy Wheeler seconded the motion.

- 4. The second payment for Mortgage Tax was received \$8140.42, bringing the total this year to \$14,506.51.

WITNESSETH

That the party of the second part, in consideration and payment to it by the party of the first part, the sum of money to be paid in the manner and the times hereinafter described, hereby covenants and agrees that:

- 1. The party of the first part duly designates and appoints <u>James McHugh</u> to carry out the duties and responsibilities of the <u>Animal/Dog Control Officer</u> in the enforcement of the provisions of <u>Article #7</u> of the <u>Agriculture and Markets Law.</u>
- 2. The party of the second part shall provide and maintain a shelter or pound for seized dogs and follow Article #7 of the Agriculture and Markets laws as to any regulations pursuant to seizure, holding, care, redemption, adoption, and disposition of seized dogs. This includes all violations of local laws pertaining to dogs within the municipality.
- 3. The party of the second part will file and maintain a complete record of all seizures and the subsequent disposition of any dog in the manner prescribed by the Commissioner of the Department of Agriculture and Markets as well as, any other records required by Article #7 or party of the first part.
- 4. In consideration of the performance by the party of the second part of the terms of this agreement, the party of the first part hereby agrees to pay the party of the second part the sum of § 3,000.00, which includes mileage for the period of January 1, 2024 through and including December 31, 2024, payable in two equal payments due in January and September.
- 5. The party of the second part shall house all dogs seized in the municipality at the Town of Bangor Sheltering, P.O. Box 337, County Route 8, Bangor, NY 12966. The Town of Bangor Sheltering shall collect and keep from the owner of any dog, dog claimed to be owned, whether or not identified as owned, a \$15.00 per day boarding fee. For dogs seized and/or required to be held by seizure, confinement, quarantine, order of the Health Department, Police Agency, Justice of the Peace, Dog Control Officer or for any other reason, The Town of Bangor Sheltering must house a dog owned, or claimed to be owned, by the complaint of another.
- 6. The party of the first part hereby agrees that this agreement covers dogs seized within the Town of Burke in violation of Article # 7 and any Local Town Dog Control Law. At the end of the mandated redemption period, said dog is no longer the property of the municipality, and shall be turned over to Town of Bangor Sheltering for adoption, turned over to another rescue entity, or euthanized.
- 7. The part of the second part and Town of Bangor Sheltering shall indemnify and hold the party of the first part harmless from and against any and all liabilities, suits, claims, demands, actions, proceedings, judgements, orders, costs and expenses, including reasonable attorney's fees, in any way relating to or arising from or out of the actions or omissions of the party of the second part, its officers, employees or agents, in the performance of the terms of this Agreement; party of the second part and Town of Bangor Sheltering shall name the party of the first part as an additional named insured on their liability insurance policy.
- 8. The party of the second part will properly care for all dogs in such shelter and will humanely euthanize or make available for adoption seized dogs not redeemed as provided in Article #7 of the Agriculture and Markets Law

and the Municipality's Local Laws. Such shelter shall at all times of the terms of this agreement be under the care and charge of a competent employee and shall be open to the public at reasonable hours.

This agreement shall commence on <u>January 1, 2024</u> and shall continue and include <u>December 31, 2024</u> .
